A local law ADOPTING THE VETERANS ALTERNATIVE EXEMPTION FROM REAL PROPERTY TAXES PURSUANT TO REAL PROPERTY TAX LAW SECTION 458-a

Be it enacted by the BOARD OF TRUSTEES of the

Section 1. The Board of Trustees of the Village of Margaretville hereby repeals Local Law 2 of 1984 titled "A local law in relation to the alternative veterans exemption from real property taxation". Commencing on the effective date of this Local Law, said Local Law 2 of 1984 shall be of no further force and effect.

Section 2. The effect of the repeal of Local Law 2 of 1984 as set forth in Section 1 of this Local Law is to adopt the veterans alternative exemption from real property taxes as set forth in Real Property Tax Law Section 458-a commencing with the 2001-2002 tax year of the Village of Margaretville.

Section 3. The Board of Trustees of the Village of Margaretville elects to use the maximum exempt values authorized by state law as set forth in Real Property Tax Law Section 458-a rather than adopting one of the lower or higher sets of maximum exempt values that could be adopted by local law.

Section 3. This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York.
